End of Contract	<p>This Agreement does not renew automatically.</p> <p>At the end of the contract term, if you do not choose a new product, your account will move to a month-to-month variable product. Prior to the expiration of your contract term, you will receive two renewal reminders; one at 60 days and one at 45 days, which will outline your options for renewal.</p>
